COMPANY OVERVIEW

We are a public gas and water utility located in Trussville, Alabama, serving approximately 25,000 customers. We operate about 547 miles of high pressure (61-250 psi) and low pressure (<60 psi) natural gas distribution pipelines in Jefferson, St. Clair County, and Blount Counties.

NATURAL GAS SAFETY

As the local natural gas utility for Trussville and surrounding areas, it is our goal to provide safe and reliable services for our natural gas customers and the surrounding communities. Like other natural gas companies, we set high standards to keep our pipelines incident free. Our pipeline is regulated by several federal and state government agencies including the Pipeline Hazardous Materials Safety Administration and the Alabama Public Safety Commission. We strive to meet and exceed the standards for safety required by these agencies.

While pipeline issues are rare, understanding gas safety can help keep communities safe.

If you observe any unusual or suspicious activity near our pipeline facilities or in the unlikely event an emergency occurs, please call us at any time using the contact numbers listed in this document.

SIGNS OF A NATURAL GAS PIPELINE LEAK?

- Rotten egg smell
- Blowing or hissing sound
- Dust blowing from a hole in the ground
- Continuous bubbling in wet or flooded areas
- Dead or discolored vegetation in a green area
- Flames, if a leak has ignited

WHAT TO DO IF A PIPELINE LEAK IS SUSPECTED?

Leave the area IMMEDIATELY!

- DO NOT use anything that could create a spark and ignite the gas – including a cell phone.
- DO NOT use any electrical device, such as light switches, telephone, cell phones, garage door openers.
- DO NOT use an open flame, matches or lighters.
- DO NOT try to locate the source of the leak.
- DO NOT try to shut off any natural gas valves or gas appliances - leave that to the experts.
- DO NOT start or move vehicles.
- DO NOT re-enter a building or return to the area of the suspected leak until trained staff has indicated that the area is safe.

PIPELINE MARKERS

Pipeline markers are used to indicate the approximate location of a natural gas pipeline and to provide contact information for the pipeline operator. Markers should never be removed or relocated by anyone other than a pipeline operator.
