SIGNS OF A PIPELINE LEAK COULD INCLUDE

- Pooling of liquid on the ground near a pipeline
- Rainbow sheen on water
- Dead or discolored vegetation near a pipeline
- Strange gaseous or hydrocarbon odor
- Continuous bubbling in wet or flooded area
- Dust or dirt blowing from a hole in the ground
- Fire or explosion near a pipeline
- Low-lying, dense white cloud/fog originating near a pipeline
- Unusual roaring or hissing sound

WHAT DOES EASTON ENERGY DO IF A LEAK OCCURS?

PROTECT LIFE

- Notify local emergency responders
- Assess the situation and work with responders to secure the area and set up a safe perimeter
- Assist responders with controlling traffic, evacuating personnel, provide rescue or first aid services

MITIGATE SITUATION

- Isolate the emergency area by closing the appropriate valves
- Shut down the impacted facilities
- Eliminate sources of ignition
- Work with emergency response agencies as appropriate
- Deploy booms or containment devices to minimize environmental impact
- Other steps included in our Emergency Response Plans

PIPELINE LOCATION AND MARKERS

Pipeline markers are used to indicate the approximate location of pipelines and to provide contact information. Aerial patrol craft can also use the markers to identify the pipeline route. Markers should never be removed or relocated by anyone other than a pipeline operator.

PRODUCT	LEAK TYPE	VAPORS
NGLS, REFINED PRODUCTS AND PETROCHEMICALS	Primarily Gas; potential for some liquid pooling	Mostly lighter than air which will generally rise and dissipate, some may gather in low areas or confined spaces and travel to a source of ignition.
HEALTH HAZARDS	Will be easily ignited by heat, sparks or flames and will form explosive mixtures with air. Vapors may cause dizziness or asphyxiation without warning and may be toxic if inhaled at high concentrations. Contact with gas or liquefied gas may cause burns, severe injury and/or frostbite.
