**INCIDENT COMMAND SYSTEM**

COP utilizes an expandable Incident Command System. Depending upon the size and complexity of an incident, additional Company or contract personnel may be added and federal, state or local agencies may be integrated by utilizing the Unified Command Structure.

**OIL SPILL CONTRACTORS**

Certified Oil Spill Response Organizations (OSROs) are under contract by COP for use in this area. Spill Response contractors are used globally, while OSROs that are close to assets in this area are also identified and under contract for use in an incident. The Company Emergency Response Plan contains the specific contact and resource information for these companies. In addition, these OSROs are invited to participate in training and pre-planning exercises with our local and regional response teams. These OSROs and Co-ops can be relied upon for an appropriate level of response with spill response equipment and trained personnel.
