WHAT DOES JAY-BEE OIL & GAS, INC. PIPELINE DO IF A LEAK OCCURS?

To prepare for the event of a leak, pipeline companies regularly communicate, plan and train with local emergency responders. Upon the notification of an incident or leak, the pipeline company will immediately dispatch trained personnel to assist emergency responders.

Pipeline operators and emergency responders are trained to protect life, property and facilities in the case of an emergency.

Pipeline operators will also take steps to minimize the amount of product that leaks out and to isolate the pipeline emergency.

We ask for your help in identifying possible gas leaks and reporting any activity on or near our rights-of-way which might cause damage to our pipeline.

Additionally, we will:

- 1. Shut down the pipeline and isolate the problem
- 2. Identify hazards
- 3. Excavate and repair the damaged pipeline.

MAINTAINING SAFETY AND INTEGRITY OF PIPELINES

Jay-Bee Oil & Gas, Inc. invests significant time and capital maintaining the quality and integrity of our pipeline systems. Personnel monitor the pipeline system and assess changes in pressure and flow. They can notify field personnel if there is a possibility of a leak. Product: Natural Gas **Leak Type:** Gas

Vapors: Lighter than air and will generally rise and dissipate. May gather in a confined space and travel to a source of ignition.

Vapors may cause dizziness or asphyxiation without warning and may be toxic if inhaled at high concentrations. Contact with gas or liquefied gas may cause burns, severe injury and/or frostbite.


