**A SAFE, EFFICIENT ENERGY TRANSPORTATION SYSTEM**

Kinder Morgan is a company that cares about communities where we operate. This includes raising awareness and educating those stakeholders who are near and/or impacted by our pipeline operations.

To supply Arizona with petroleum fuel, Kinder Morgan operates pipelines that originate from the coast of California as well as a gathering system in El Paso Texas. These multi-products pipelines coming in from the east and the west are utilized to deliver several grades of gasoline, diesel, and jet fuel to the Arizona market. In Arizona Kinder Morgan utilizes steel pipelines that are 6", 8", 12", and 20" in diameter and operate at pressures ranging from 10-1200 PSI. There are also 6" lines which are dedicated solely to the delivery of military grade jet fuel (JP-8) directly to military installations.

**COMMITMENT TO SAFETY, HEALTH & ENVIRONMENT**

**Pipeline Safety**

Kinder Morgan's goal is to prevent accidents, ensure the public's safety, and protect the environment; Kinder Morgan cares about the environment. We design, install, test, operate, and maintain our pipelines to meet or exceed regulatory standards. Our employees are thoroughly trained to operate and maintain the system safely.

Kinder Morgan relies on you and the local emergency responders, to notify Kinder Morgan when you observe potential right-of-way restriction violations or potential damage to our facilities, which could endanger the public safety or the environment. We support the enforcement of "Call Before You Dig" requirements in the states where they apply.

**Pipeline Maintenance and Monitoring**

In addition to 24-hour monitoring and on-going safety and security procedures, Kinder Morgan regularly conducts maintenance to trim trees and remove shrubs or structures that prohibit clearly viewing the pipeline corridor. We conduct scheduled aerial, and vehicle patrols of the pipeline corridor. To ensure the integrity of the Kinder Morgan system, electronic inline inspection tools are scheduled to inspect the line for dents and metal loss. The pipeline and associated facilities use an induced cathodic protection system preventing external corrosion.

**Pipe Markers**

Since Pipelines are buried underground, line markers are used to indicate the approximate - not exact - location of the pipeline, the products transported, the company operating the pipeline, and the emergency number. Line markers can be found where a pipeline intersects a street, highway, or rail road. The pipeline may not follow a straight course between markers. Markers provide no information to the depth or number of pipelines in the vicinity.

**One Call Systems**

We need your help preventing pipeline emergencies. The number one cause of a pipeline leak is damage from earth-moving and construction equipment. If you plan to dig or do any type of excavation or construction work, call your state underground utilities locating service "One Call Center" or 811. A Kinder Morgan representative will locate and mark the underground lines at no cost to you. Call at least 48 hours (excluding weekends and holidays) before you dig.


