**ABOUT KAISER-FRONTIER MIDSTREAM LLC**

Kaiser-Frontier Midstream LLC is a private company that owns and operates a natural gas transmission pipeline in Laramie County, WY, and Weld County, CO. The pipeline system is comprised of approximately 3.3 miles of 4" pipe, 16.7 miles of 6" pipe, and 14.5 miles of 8" pipe.

**COMMITMENT**

Kaiser-Frontier Midstream LLC is committed to the protection of the public and the environment through the safe operation and maintenance of its pipeline systems.

Kaiser-Frontier Midstream LLC has committed the necessary resources to fully prepare and implement its emergency response plans and has obtained through contract the necessary private personnel and equipment to respond, to the maximum extent practicable, to a "worst case" discharge or substantial threat of such a discharge.

**WHAT DOES KAISER-FRONTIER DO IF A LEAK OCCURS?**

Kaiser-Frontier Midstream LLC is committed to operating and maintaining our pipelines in a safe manner. In the

unlikely event of a pipeline release, Kaiser-Frontier will take the following steps to ensure public safety and protect the environment:

- a. Shut down the pipeline
- b. Identify hazardous areas
- c. Ensure the safety of the public
- d. Dispatch personnel and emergency responders to the scene
- e. Excavate and repair the damaged line
- f. Work with emergency responders, the public and officials in the affected area

**DAMAGE PREVENTION**

Kaiser-Frontier Midstream LLC is committed to protecting our pipelines from third party damage. We do this by clearly marking our pipeline right of ways, participating in the Colorado One-Call program and by routinely patrolling and inspecting our pipeline right of ways.

**COMMUNICATIONS**

Kaiser-Frontier Midstream LLC utilizes its 24-hour answering service (1-800-876-7023) as a hub of communications in emergency response situations. On-site communications are conducted using cellular telephones and/or land-line telephone systems from Company facilities and offices.
