Enable Midstream Partners, LP operates two interstate natural gas pipelines, Enable Gas Transmission and Southeast Supply Header (SESH) in Mississippi. Note: See SESH Operator Page for more information. Enable Gas Transmission and SESH have approximately 300 miles of pipeline in the state of Mississippi.

In addition, we operate Enable Midstream Partners, LP, a natural gas mid-stream company that provides gas gathering, processing and treating services to producers throughout the mid-continent region of the United States. Enable Midstream Partners has approximately 50 miles of gathering pipeline in the state of Mississippi.

To view and download maps of all transmission pipelines in your county, see the National Pipeline Mapping System website (www.npms.phmsa. dot.gov), an online mapping program managed by the federal government. Pipeline markers are placed along the pipeline route to indicate the





approximate location of the line and to identify where the pipeline intersects with a street, highway, railway or river. Markers display the material transported in the line, the name of the pipeline operator and an emergency telephone number.

### **COMMITMENT TO SAFETY, HEALTH** & THE ENVIRONMENT

Enable Midstream's primary concern is safe and reliable delivery of natural gas. According to the National Transportation and Safety Board, pipelines are the safest and most economical way to transport products. We are committed to the safe operation of our pipelines in your community. We monitor the operations of our pipelines 24 hours a day, seven days a week from our control centers. Our pipelines are designed, installed, tested, operated and maintained in accordance with all applicable federal and state requirements. Public education includes educational outreach with excavating contractors, emergency response officials, appropriate public officials, and the affected public.

## **EMERGENCY PLANS**

If a gas pipeline emergency were to occur, Enable Midstream personnel will work directly with local emergency responders. Our priorities at the scene of a pipeline emergency are the same as yours-- protect life, property and the environment. Many Enable Midstream field personnel are trained in Incident Command Structure (ICS) and familiar with how to work with local responders within the ICS framework. Enable Midstream personnel will restrict the flow of gas and implement other operating actions as needed to minimize the impact of the emergency. Public safety officials and other non-company personnel should not attempt to operate pipeline valves. Improper operation of pipeline valves can cause other accidents to occur.
