Southeast Supply Header LLC (SESH) is a joint venture between Enable Midstream Partners, LP and Spectra Energy Transmission. SESH is a transmission pipeline delivering natural gas supplies to the growing Southeast U.S. market. The 286 mile pipeline transports natural gas supplies from the Perryville Hub in northern Louisiana to interconnecting pipelines serving the eastern U.S. It terminates at the Gulfstream Natural Gas System near southern Mobile County, Alabama. Plant Daniel intrastate transmission pipeline connects SESH to the Daniel Electric Generating plant in Jackson County.

SESH is committed to the safe and reliable operations of our pipelines. We monitor our pipelines, which are designed, installed, tested, operated and maintained in accordance with all applicable federal and state requirements. We maintain our safety record with routine inspections, corrosion protection, maintenance and testing programs, employee training, integrity management program and public awareness program. Public awareness includes educational outreach to excavating contractors, emergency response offices, appropriate public officials and the affected public.

**SOUTHEAST SUPPLY HEADER'S ACTIONS DURING AN EMERGENCY:**

Many of our field personnel are trained in the Incident Command System (ICS) and will immediately dispatch personnel to the site to help handle an emergency and provide information to public safety officials to aid in their response. We will also take necessary operating actions to minimize the impact of an emergency. Public safety personnel and other unauthorized personnel should not attempt to operate any pipeline valves.

Improper operation of pipeline valves could make a situation worse and cause other accidents.
