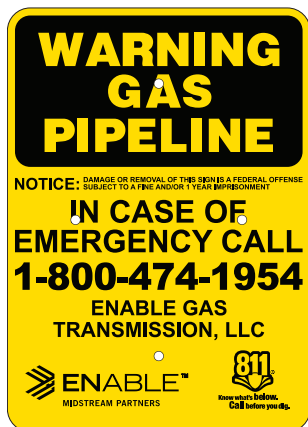




Enable Midstream owns interstate and intrastate natural gas pipelines, as well as a gas gathering operation, processing and treating services. In addition, we own crude oil gathering and hazardous liquid lines. In Missouri, we operate Enable Gas Transmission (EGT) and Enable Mississippi River Transmission (EMRT), our interstate natural gas transmission lines.

LOCATING PIPELINES

To view and/or download maps of all pipelines in your county, see the National Pipeline Mapping System website (www.npms.phmsa.dot.gov), an online mapping program managed by the Federal Government. Pipeline markers are placed along the pipeline route to indicate the approximate location of the line and to identify where the pipeline intersects with a street, highway, railway or river. Markers display the material transported in the line, the name of the pipeline operator and an emergency telephone number. They do not indicate the exact location or depth of the pipeline.



COMMITMENT TO SAFETY, HEALTH & ENVIRONMENT

Enable Midstream Partners is committed to the safe and reliable operations of its pipelines in your community. According to the National Transportation Safety Board, pipelines are the safest and most economical method of transporting products. We monitor the operation of our pipelines from our control centers, 24 hours a day, seven days a week. Our pipelines are designed, installed, tested, operated and maintained in accordance with all applicable federal and state requirements. Our safety education efforts include outreach with excavating contractors, emergency response officials, appropriate public officials, farmers and affected public.

If a gas pipeline emergency were to occur, Enable Midstream personnel will work directly with local emergency responders. Our priorities at the scene of a pipeline emergency are the same as yours-- protect people, property and the environment. Many Enable Midstream field personnel are trained in Incident Command Structure (ICS) and familiar with how to work with local responders within the ICS framework. Our personnel will restrict the flow of gas and implement other operating actions as needed to minimize the impact of the emergency. Public safety officials and other non-company personnel should not attempt to operate pipeline valves. Improper operation of pipeline valves can cause additional accidents to occur.
