Energy Transfer Partners, a Texas-based energy company founded in 1995 as a small intrastate natural gas pipeline company, is now one of the largest and most diversified master limited partnerships in the United States. Strategically positioned in all of the major U.S. production basins, the company owns and operates a geographically diverse portfolio of energy assets, including midstream, intrastate and interstate transportation and storage assets. Energy Transfer operates more than 90,000 miles of natural gas, crude oil, natural gas liquids and refined products pipelines and related facilities, including terminalling, storage, fractionation, blending and various acquisition and marketing assets in 38 states.

- Intrastate Transportation and Storage Operations – approximately 7,900 miles of natural gas pipelines and three storage facilities.
- Interstate Transportation and Storage Operations – approximately 19,000 miles of natural gas pipelines; 10,770 miles of crude oil pipelines; and 2,200 miles of refined products pipelines along with 40 refined products marketing terminals.

- Midstream Operations – approximately 40,000 miles of natural gas gathering pipelines and more than 60 processing, treating and conditioning plants.
- NGL Transportation and Services – approximately 4,800 miles of NGL pipelines, three processing plants, four fractionation facilities and NGL storage facilities with aggregate working storage capacity of approximately 53 million Bbls.

Company is an approximately 6,000-mile natural gas pipeline system with access to diverse supply sources and extends from producing areas in the Anadarko Basin of Texas, Oklahoma and Kansas through Missouri, Illinois, Indiana, Ohio and into Michigan. Our Midwest customer base includes some of the nation's largest utility and industrial natural gas users.
