**OPERATOR OVERVIEW**

Magellan Midstream Partners, L.P. transportation and terminal services provide the highest standards for product quality, information technology, environmental compliance and, most important of all, customer service and satisfaction.

Magellan personnel have been Hazwoper trained to the technician level. Magellan has response equipment located at strategic locations. Magellan has contracted with several OSRO groups. Magellan uses cell phones and 2-way communications and has partnered with state and local response agencies.

**COMMITMENT TO SAFETY, HEALTH & ENVIRONMENT**

When managing an emergency, protecting lives and the environment requires a concerted team effort with local emergency responders. Magellan routinely works with local emergency responders and planning agencies to ensure safe operations of our facilities. Our representatives meet regularly with firefighters, emergency management officials, law enforcement officers, public officials and planning agencies to review Magellan's enhanced emergency response procedures and conduct annual emergency response drills.. Magellan representatives regularly meet with public officials in the communities in which we operate. We strive to share information about our operations and facilities, as well educate officials about our pipeline safety.

Magellan's commitment to make its pipeline safe for the environment and the citizens of New Mexico includes the adoption of safety measures that go to unprecedented lengths to address leak detection and control, and to prevent the four leading causes of pipeline failures: outside force damage, corrosion, operator error and material defects. Pipelines are generally underground and out of sight, but they're not out of mind. To ensure safe operation of our pipeline system and maintain operational integrity, dispatchers watch operations around the clock with computers and satellites in Magellan's control room which is monitored on a 24 hour a day basis, by trained and qualified pipeline controllers. Alarms and meters are designed to detect unusual changes in pressure or flow. Through the analysis of this information and pipeline conditions, automated emergency shutdown systems can be activated quickly in the unlikely event of a pipeline leak.

Emergency responders and local planning / zoning authorities may obtain detailed maps of our systems from field operations staff. Field operations personnel have copies of emergency response plans. If interested in learning more about our facility response plan, please see a field representative, or contact this office.

Magellan Pipeline, like other pipeline operators, is required to prepare and follow written procedures for handling abnormal operations. We have developed an emergency response guidebook, as well as the enhanced facility response plan, that contains written procedures for responding to an incident. It is designed to help employees quickly evaluate and effectively manage an incident to limit its consequences. Magellan utilizes the incident command system.

**INTEGRITY MANAGEMENT PLAN**

Leadership, commitment and support establish the foundation upon which the Magellan System Integrity Plan (SIP) is built. Meeting or exceeding the applicable laws, regulations and Mitigation Commitments is a basic requirement. The objective of Magellan's System Integrity Plan is: 1) to ensure long-term success through active and visible commitment and participation by all company employees; and 2) to describe processes used to establish SIP goals.
