**OVERVIEW**

Boardwalk Ethane Pipeline Company, LLC (BEP), Boardwalk Louisiana Midstream, LLC (BLM), and Boardwalk Purity Pipelines Company, LLC (BPC) are subsidiaries of Boardwalk Pipelines, LP (Boardwalk).

Together BEP and BPC (referred to as Bayou Ethane) transport ethane between Mont Belvieu, Texas and Baton Rouge, Louisiana, where it interconnects with the ethane distribution system and Boardwalk's storage facilities on the Mississippi River. Bayou Ethane also provides connectivity to Boardwalk's Sulphur storage facilities, located near the emerging Lake Charles petrochemical corridor.

BLM provides liquids storage and pipeline transportation as well as brine supply services for regional producers and consumers of petrochemicals, natural gas liquids, olefins and natural gas. Operations are conducted through strategically located hubs serving two petrochemical industrial centers in Louisiana as well as one interstate ethylene pipeline, Evangeline Pipeline, owned by BLM's affiliate, Boardwalk Petrochemical Pipeline, running from East Texas to the Mississippi River Corridor.

**COMMITMENT TO SAFETY, HEALTH & THE ENVIRONMENT**

Boardwalk is committed to the protection of the public and the environment through the safe operation and maintenance of its pipeline systems. Boardwalk's qualified personnel are trained in emergency response activities and regularly participate in drills and exercises reflecting various types of response levels, emergency scenarios, topographic terrain and environmental sensitivities. Boardwalk has committed the necessary resources to fully prepare and implement its emergency response plans.

**COMMUNICATIONS**

Boardwalk utilizes its 24-hour Pipeline Control Center (BLM: 1-866-574-4483; BPC and BEP: 1-866-506-7160) as a hub of communications in emergency response situations.

The Control Center has a vast catalog of resources and capabilities. On-site communications are conducted using cellular telephones, portable radios, satellite phones and/or land-line telephone systems from company facilities and offices.

**PIPELINE LOCATION AND MARKERS**

The purpose of a pipeline marker is to identify a pipeline right-of-way and to provide information about Boardwalk's pipelines including operator name; phone numbers, in case of a possible emergency; and the product inside. Markers indicate the general, not exact, location of a pipeline and do not necessarily follow a straight course between two markers. Never rely solely on the presence or absence of pipeline markers - someone may have moved or removed the marker.

**IN CASE OF AN EMERGENCY**

Emergency preparedness and planning measures are in place at Boardwalk in case a pipeline incident occurs. Boardwalk also works closely with local emergency response organizations to educate them regarding our pipelines and how to respond in the unlikely event of an emergency.

Should an emergency occur, Boardwalk's objective is to resolve the situation quickly and safely. Two-way communication with emergency responders is critical for this resolution.
