To prepare for the event of a leak, pipeline companies regularly communicate, plan and train with local emergency responders. Upon the notification of an incident or leak the GPC will immediately dispatch trained personnel to assist emergency responders.

Pipeline operators and emergency responders are trained to protect life, property and facilities in the case of an emergency.

Pipeline operators will also take steps to minimize the amount of product that leaks out and to isolate the pipeline emergency.

**MAINTAINING SAFETY AND INTEGRITY OF PIPELINES**

We believe it is our responsibility to be good neighbors and maintain a strong commitment to damage prevention and safety through the implementation of industry developed best management practices and monitoring of our operations. Contact a Texas one call center by calling 811 or visiting [www.texas811.org](http://www.texas811.org) at least 48 hours in advance (two business days, excluding weekends and holidays) before you dig.

**RECOGNIZING A LEAK**

In the unlikely event of a pipeline leak: You might see, hear, or smell

- Dirt being blown into the air Sight
- Discolored vegetation 
- A white vapor stream or mist-like cloud Sound
- A roaring, blowing, or hissing sound 
- An unusual sulfur or rotten egg odor Smell

**RESPONDING TO A LEAK**

**EVACUATE THE AREA IMMEDIATELY**

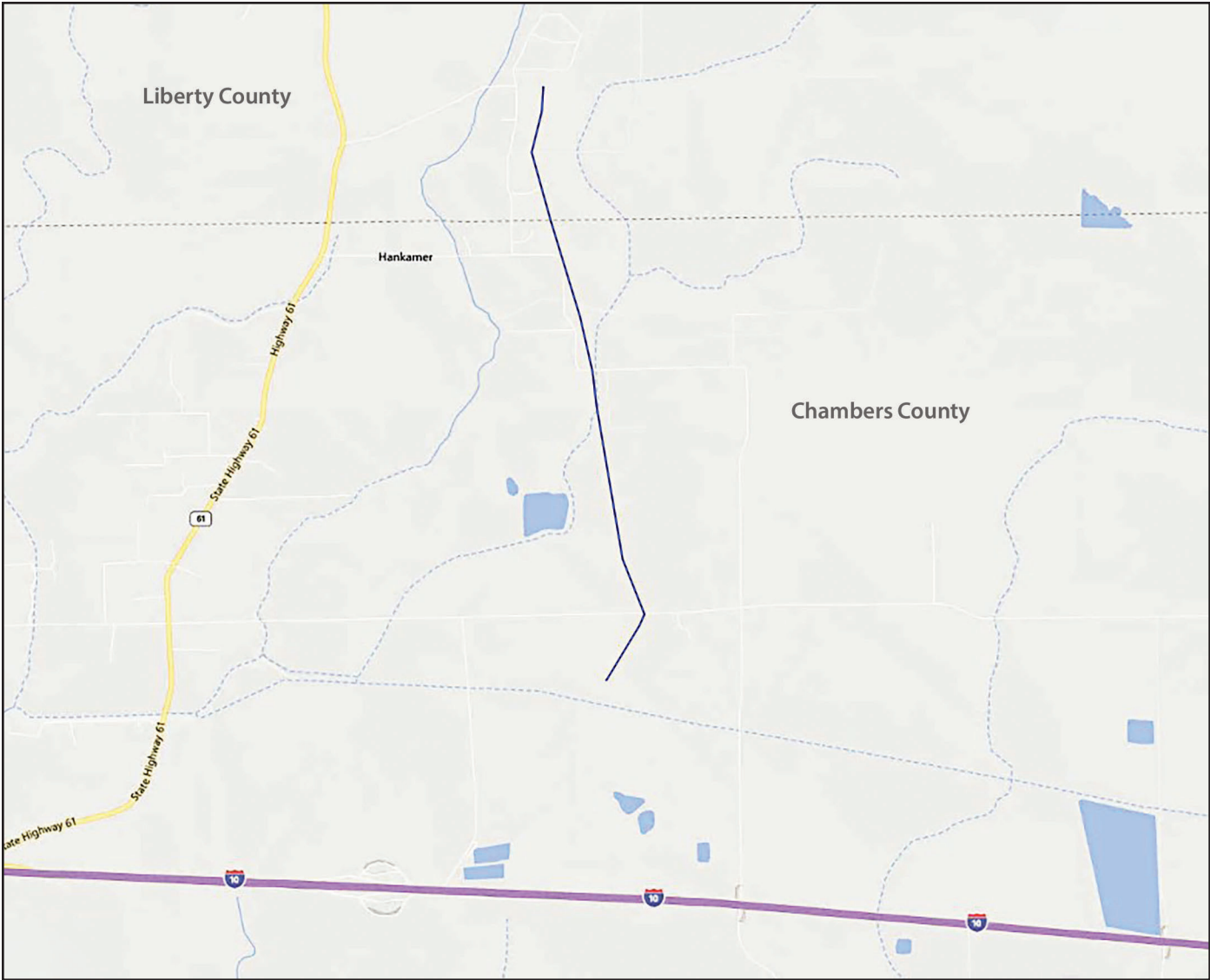
- Abandon any equipment being used in the area
- Move upwind of the product release
- Avoid open flames
- Avoid introducing any sources of ignition
- Do not start or turn off motor vehicles or electrical equipment
- Call our 24 hour emergency number and 911

**PRODUCTS TRANSPORTED IN YOUR AREA**

PRODUCT	LEAK TYPE	VAPORS
<b>NATURAL GAS</b>	Gas	Lighter than air and will generally rise and dissipate. May gather in a confined space and travel to a source of ignition.
<b>HEALTH HAZARDS</b>		Will be easily ignited by heat, sparks or flames and will form explosive mixtures with air. Vapors may cause dizziness or asphyxiation without warning and may be toxic if inhaled at high concentrations. Contact with gas or liquefied gas may cause burns, severe injury and/or frostbite.
