**ABOUT OXY VINYLs, LP (OXYVINYLs) PIPELINES**

OxyVinyls has several pipelines that interconnect the five (5) OxyVinyls facilities in the Pasadena, Deer Park and LaPorte, Texas, area. Only two (2) of these pipelines are regulated by PHMSA: a natural gas supply pipeline to the OxyVinyls LaPorte facility and a natural gas supply pipeline to the OxyVinyls Pasadena facility.

**WHAT DOES OXYVINYLs DO IF A LEAK OCCURS?**

To prepare for the event of a leak, OxyVinyls regularly communicates, plans and trains with local emergency responders. Upon the notification of an incident or leak OxyVinyls will immediately dispatch trained personnel to assist emergency responders.

OxyVinyls and emergency responders are trained to protect life, property and facilities in the case of an emergency.

OxyVinyls will also take steps to minimize the amount of product that leaks out and to isolate the pipeline emergency.

**MAINTAINING SAFETY AND INTEGRITY OF PIPELINES**

OxyVinyls invests significant time and capital maintaining the quality and integrity of their pipeline systems. Active pipelines are monitored 24 hours a day via manned control centers. OxyVinyls also utilizes aerial surveillance and on-ground observers to identify potential dangers. Control center personnel continually monitor the pipeline system and assess changes in pressure and flow in designated pipelines. They notify field personnel if there is a possibility of a leak. Automatic shut-off valves are sometimes utilized to isolate a leak.
